85% of Europe's land is covered by rural areas which are inhabited by 137 million people (2018 Eurostat report). Nevertheless a 2019 Eurostat report found that 22% of Europe's rural population is at risk of poverty and social exclusion. [RUBIZMO](#) and [LIVERUR](#) - two Horizon 2020 projects identified innovative ideas for rural jobs and growth! At their Final Event on the 7th of October their results and tools will be presented to policymakers, advisors and rural entrepreneurs, as well as to the interested public audience. The event presents the opportunity to discuss and plan for the large-scale replication of innovative business models supporting sustainable growth and job creation in European rural areas.

Hosted by the European Economic and Social Committee (EESC), Peter Schmidt, the President of the NAT Section will open the event. During the panel discussion "Policy in Practice - How to support Europe's rural entrepreneurs" founders of agricultural start-ups like Christine Hebert from Blue Lobster and Oana Maria Iliescu from Taina Vie will give insights in their secrets of success. Next to those experts in the field Piroska Kálay (EESC), David Lamb (ENRD) and Emilija Stojmenova Duh (University of Ljubjana) will share their knowledge on rural development.

In the first workshop round the participants will be able to learn more about the different tools the projects developed like the [Virtual Library](#) featuring 38 business cases, the [Transformation Support Tool](#) and the [RAIN concept](#). In a second workshop round it's all about Cross-Regional Learning. Here best practices of how each region/partner facilitated rural innovation will be promoted and practical examples identified throughout the two projects will be featured.

Peter Schmidt

President of the NAT Section of the European Economic and Social Committee - Welcome Address

Since 2014 Peter Schmidt is a member of the European Economic and Social Committee and since 2018 the president of the NAT Section. The section deals with Agriculture, Rural Development and the Environment and is responsible for a broad range of issues, like the common agricultural policy (CAP), food sustainability, environmental protection, circular economy, the implementation for the UN Sustainable Development Goals (SDGs) and climate change.

Alexia Rouby

Research and Innovation Unit, Directorate-General for Agriculture and Rural Development, European Commission - Introduction

Alexia Rouby is an agro-economist with 18 years of experience in network coordination, policy analysis, project development and management and since 2014 Research Programme Officer at the European Commission. Within the Agriculture and Rural Development department of the European Commission, in the research and innovation unit she manages Horizon 2020 projects dealing with agriculture and rural development, rural resilience, urban farming and largescale initiatives to accelerate the transition to agroecology.

In August 2018 she founded the start-up [Blue Lobster](#) - an online platform dedicated to directly connect sustainable fishermen with their customers. The entrepreneur has a master's degree in environmental and Natural Resource Economics and worked at different companies as data analyst and editor till she founded Blue Lobster together with her colleague Nima Tisdall.

Founder of [Taina Vie](#) - Panel Discussion

In 2010 Oana Maria Iliescu together with her husband Dragos founded [Taina Vie](#), near Iasi, Romania. They produce organic honey and honey products and at the same time offer traditional ceramics as well as touristic activities like e-bike tours and workshops. The start-up received regional funding and in 2019 they won the RUBIZMO Rural Business Innovation Award.

Emilija Stojmenova Duh

Next to being an assistant professor at the Faculty of Electrical Engineering at the University of Ljubljana, Emilija Stojmenova is head of the public, private, people partnership digital innovation hub 4P DIH, whose main aim is to provide services to grow digital competencies, share digital experience and support the government to adapt regulations to foster entrepreneurship.
